REPORTS FROM PRIORITY AGENCIES

- Beverly Hills Unified School District Honorable Mary Wells, BHUSD Governing School Board Member, provided an oral presentation to the Commission. Main topics included the continued monitoring of the COVID-19 pandemic metrics, safety, contact tracing, and the reopening of school for TK-5th grade. Mary Wells highlighted that BHUSD has security and safety measures in place in anticipation of reopening. Utilizing resources like the Medical Advisory Task Force can be a proactive approach for planning and preparing in addition to the District's existing task force. Mary Wells closed the item with the recognition of late Preschool Special Education Teacher, Lynn Gifford, who dedicated 25 years of service
- Beverly Hills Police Department Acting Police Captain Max Subin updated the Commission on various police activities. Topics included the Department's first Explorer meeting of the year held on February 14, 2021, private armed security companies that assist in patrolling the City by providing extra visibility in the community, and information and safety tips regarding home burglaries. Acting Captain Subin introduced the City's new program, JUST IN CASE, BH at the Explorer meeting.
- Beverly Hills Fire Department A-Shift Platoon Battalion Chief Timothy Hayes updated the Commission on various Fire Department activities including the latest incident and response statistics, Red Flag Activation/Strike Team deployment, and the major incident deployments for structure fires and a carbon monoxide emergency in the City.

CONTINUED BUSINESS

1. Smoking and Tobacco Informational Update

Executive Assistant Gabrielle Ressa provided a smoking and tobacco informational update to the Commission. Topics of discussion included current hardship exemption application appeals, education and soft enforcement by Smoking Ambassadors, California State Legislature, and smoking cessation. The City conducted community outreach including advertising in local publications and the Code Enforcement Division will perform inspections at the City's tobacco retailers to ensure compliance with the new ordinance prohibiting the sale of tobacco products in the City.
